Course Description:

Finance is normally divided into corporate finance and investments. Corporate finance describes how businesses analyze investment opportunities and then finance those investments. Investments looks at the subject from the other side, namely the financial instruments generated by businesses (and governments too) in order to finance operations, how these investments work, and the risk of and return on these investments. This course seeks to give students a basic understanding of those financial instruments: stocks, bonds, investment funds (such as mutual funds), and derivatives (such as futures and options). It also seeks to give students are bought and sold and of the exchanges on which these investments are traded. The course will stress an understanding of the terms used when discussing finance. It will also look at how some of these investments were involved in the 2008 financial meltdown.

Course Goals & Objectives:

The goal of this course is to give students an understanding of the different types of investmens available in the capital markets (such as stocks, bonds, various funds, and derivatives), how these investments are bought and sold, and the exchanges that they are bought and sold on. Another goal is to make students aware of the terms used when discussing investments. A third goal is to make students aware of the concepts risk and return. A final goal is to make students aware of how some of these investments were involved in the 2008 financial crisis.
